3. Operating hours of the booth are as follows:
5 October 2019 12 noon to 7 pm
6 October 2019 8:30 pm to 7 pm
7 October 2019 8:30 pm to 2 pm
4. Booth operators can display their products ONLY in the rented area. Stock can be placed under the table or next to the chairs behind the table.
5. Only products stated in the application can be displayed.
6. A maximum of two persons will be allowed to man each table of 30" x 6'.
7. The applicant should ensure that the products do not infringe or breach in any way any right, (including but not limited to intellectual property rights) of any person or entity and do not constitute a contravention of any applicable law whether of Hong Kong SAR or any other country.
8. The 20th Zonta District Conference has the sole discretion in allocating the location and position of all booths at the Marketplace Venue.
9. If the Marketplace should be cancelled due to unforeseen circumstances, all fees paid shall be fully refunded without interest.
